HRP Associates, Inc. and our legal partner Halloran & Sage developed an innovative peer-audit program that assists groups of colleges and universities in achieving environmental compliance by utilizing on-campus personnel to conduct audits at each other's colleges under a negotiated agreement with the U.S. EPA. The program takes advantage of the U.S. EPA's "Audit Policy" which allows colleges and universities to avoid U.S. EPA inspections and significant gravity based fines by disclosing their environmental compliance violations. The program also introduces Environmental Management Systems (EMS) which allows colleges to maintain compliance and provide the next step towards sustainability.

Halloran & Sage negotiates an agreement with the U.S. EPA and, where applicable, the state environmental agency establishing the terms of the audit and disclosure of violations. A group or consortium of colleges and universities contribute a minimum of two faculty, staff and/or administrators per college to a peer-auditor pool. Halloran & Sage and HRP train these peer-auditors on the nuts and bolts of State and Federal environmental regulations, campus auditing, and environmental management systems. The newly trained "peer-auditors" audit each other's campuses with the oversight of one or more of HRP's professional auditors and the use of tablet computers loaded with auditing software. Upon receipt of the HRP prepared audit report each college discloses its environmental compliance violations to the U.S. EPA and promptly corrects those violations within a set timeframe. HRP and Halloran & Sage are available to assist the college in correcting its violations. Ultimately, the U.S. EPA provides a Notice of Determination outlining the individual college's compliance with the Audit Policy. For colleges and universities that have disclosed violations, to date, the average waived penalty per campus is \$688,844, and the range of penalties waived is a low of \$242,855 and a high of \$5,315,704. HRP and Halloran & Sage have administered the peer-audit program for more than 300 colleges and universities in ten states. To date, no college or university in the program has been assessed a gravity based fine or penalty by the U.S. EPA while achieving regulatory compliance under the peer audit program.
